



GENERAL NOTES:

1. This survey was prepared based on the Title Commitment issued by Stewart Title Guarantee Company on April 4, 2022 (effective March 28, 2022), with File No. 1592728.
2. All measured bearings, distances, coordinates, and areas are grid, based on the Texas Coordinate System of 1983 (NAD83), South Central Zone.
3. Bearings and distances shown in parenthesis are based on record information.
4. According to Fema's Flood Insurance Rate Map No. 4803850360 C, Dated August 6, 2002, the subject property is located in Flood Zone "AE" and Flood Zone "X". Flood Zone location is based on scaled FIRM only. Access Surveyors, LLC does not warrant nor subscribe to the accuracy of said FIRM.
5. The common survey line of the L. Hampshire Survey, Abstract No. 667 and the W.D. Cotton Survey, Abstract No. 105 is approximate and was determined based on scaling.
6. A Texas811 Locate Request was made under Ticket No. 2255293223. No underground facilities were marked in response to said ticket at the time of this survey.
7. According to the Railroad Commission of Texas GISViewer (<https://www.rrc.texas.gov/resource-center/research/gis-viewer>), one or more pipeline(s) not shown on this plat exist on the subject property.
8. Pipeline locations shown are based on above ground evidence, existing pipeline markers, record information, and information on the Railroad Commission of Texas GISViewer. No subsurface probing, excavation, or exploration was performed by Access Surveyors, LLC. A Texas811 locate request should be made prior to digging in this area.

Cotton Survey, Abstract No. 108, Jefferson County, Texas, being out of and a portion of the remainder of that certain called 50.49 acre tract of land described in an instrument to Thomas Louis Fore et al. of record in Film Code No. 100-63-2487, Real Property Records, Jefferson County, Texas, being all of that certain called 2.61 acre tract of land described in an instrument to Vivian Broussard Smith et al. of record in County Clerk's File No. 9829531, Official Public Records, Jefferson County, Texas, and being all of that certain tract of land described in an instrument to Vivian Broussard Smith et al. of record in County Clerk's File No. 9831966 or said Official Public Records, said 62.850 acres being more particularly described by metes and bounds as follows:

Hampshire Survey, the East line of the Jos Fannett Survey, Abstract No. 461, the Southeast corner of that certain called 5.000 acre tract of land described in an instrument to Shane Chesson of record in County Clerk's File No. 1999027100, Official Public Records, Jefferson County, Texas, the Southwest corner of said 50.49 acre tract, and being the Southwest corner of the herein described tract, said iron rod having a metes and bounds coordinate value of N 35°56'05" W 730.60'.

THENCE N 0242'30" W (called N 0030'28" E) with the East line of said Jos Fannett Survey, the West line of said L. Hampshire Survey, the East line of said 5.000 acre tract, the Southeast corner of said 5.000 acre tract, and the West line of the herein described tract, at 663.14 feet (called 663.14' feet) passing a concrete monument found marking the Northwest corner of said 2.61 acre tract and the Southeasterly line of that certain abandoned 100 foot wide right of way conveyed to Gulf and Interstate Railway Co. of Texas of record in Volume 72, Page 450, Deed Records, Jefferson County, Texas and containing a total distance of 72.87' feet to a capped iron rod stamped "ACCESS SURVEYORS" set marking the East line of said Jos Fannett Survey, the West line of said L. Hampshire Survey, the Northwesterly line of said abandoned railroad right of way, and being the Northwest corner of the herein described tract;

THENCE N 6258'36" E with the Northwesterly line of said abandoned railroad right of way and the Northwesterly line of the herein described tract a distance of 456.16' feet to a capped iron rod stamped "ACCESS SURVEYORS" set marking an angle point on the Northwesterly line of said abandoned railroad right of way and being an angle point of the herein described tract;

THENCE N 6301'39" E with the Northwesterly line of said abandoned railroad right of way and the Northwesterly line of the herein described tract a distance of 2,561.68' feet to a capped iron rod stamped "ACCESS SURVEYORS" set marking the beginning of a curve to the left;

THENCE S 6103'01" E over and across said abandoned railroad right of way and with the Northwesterly line of said 50.49 acre tract, a Southeasterly line of the herein described tract, and along said curve to the right having a Radius of 2,653.51' feet, an Arc Length of 732.93' feet, (called 746.89' feet), and a Chord which bears S 3656'07" W a distance of 730.60' feet to a concrete monument found marking the end of said curve, same being the beginning of a curve to the right;

THENCE with the Northwesterly right of way line of said State Highway 124, a Southeasterly line of said 50.49 acre tract, a Southeasterly line of the herein described tract, and along said curve to the right having a Radius of 2,343.28' feet, an Arc Length of 680.30' feet (called 679.67'), and a Chord which bears S 5324'40" W a distance of 677.91' feet to a concrete monument found marking the end of said curve;

S 6411'52" W (called S 6714'00" W) a distance of 415.17' feet to a point for the East corner of that certain called 1.1686 acre tract of land described in an instrument to Spindletop Gas Distribution Corp. of record in County Clerk's File No. 8417178 of Official Public Records, and being an exterior angle point of the herein described tract, from which a 1/2-inch iron rod found bears N 2554'05" W a distance of 0.78' feet;

THENCE N 2554'05" W (called N 2301'03" W) with the Northwesterly line of said 1.1686 acre tract and a Southeasterly line of the herein described tract a distance of 200.84' feet (called 200.00' feet) to a 1/2-inch iron rod found marking the North corner of said 1.1686 acre tract and being an interior angle point of the herein described tract;

THENCE S 6411'05" W (called S 6658'57" W) with the Northwesterly line of said 1.1686 acre tract and a Southeasterly line of the herein described tract a distance of 309.04' feet (called 309.04' feet) to a 1/2-inch iron rod found marking the West corner of said 1.1686 acre tract and being an interior angle point of the herein described tract;
